 - (ii) if the Chairman or any Member of the Authority or the Chairperson and Member of the Committee has provided consultancy services or conducted Environment Impact Assessment studies for any project

proponent during the preceding five years, in that event they shall recuse themselves from the meetings of the Authority or the Committee in the process of appraisal of any project proposed by such proponents.

- 11. The State Government of Andhra Pradesh shall specify an agency to act as Secretariat for the Authority and the Committee and the Secretariat shall provide financial and logistic support including accommodation, transportation and such other facilities in respect of their functions under the said notification.
- 12. The sitting fee, travelling allowances and dearness allowances to the Chairman and Members of the Authority and the Committee, shall be paid in accordance with the provisions of relevant rules of the State Government of Andhra Pradesh.
