





Agenda:

2. Syllabus to be designed separately for the course in Campus Colleges and affiliated colleges.
3. As per the UGC mail dated 17-10-2022, Course on Cyber Security is Mandatory for all programs from 2022-23 during first semester.
4. Preparation of program regulations, Eligibility criteria for admission into PG program, Maximum credits for each program, minimum credits to qualify the programme pass marks for each course, external, internal marks and Practical/Projects.
