**Date:20-05-2022**

An 'Anti-Ragging Awareness Programme' was conducted in the Vikrama Simhapuri University on 20-05-2022 for the Freshers. The Programme was started at 5:00 p.m. in Tikkana kala kshetram, APJ Abdul Kalam Building. M.N. Harendhira Prasad, IAS Joint Collector, Rythu Bharosa and Revenue & Ward Secretariat and Development, Nellore, was the Distinguished Guest.

The programme was started by Our University ANTHEM. After that All Guest are the welcomed by Dr. Y. Vijaya, Dy. Warden, VSU Women's Hostel welcome. She asked all guest for Lighting the Inaugural Lamp. Prof. G. Vijaya Ananda Kumar Babu, Principal (I/c), Vikrama Simhapuri University College given the Presidential Opening Remarks. The Programme Objectives were read by Dr M Hanuma Reddy, Dy. Warden, VSU Men's Hostel .He given the complete objectives of the programme. Dr L V Krishna Reddy, Registrar Guest of honour addressed the students. Sri. Dr. KVL Shrikanya Rao, Dy. Warden, VSU Women's Hostel introduced the Distinguished Guest.

The Distinguished Guest M.N. Harendhira Prasad, IAS Joint Collector, started his speech with an explanation to ragging. The new definition for ragging is : Any act of physical or mental abuse targeted at another student (fresher) on the ground of colour, race, religion, caste, ethnicity, gender, sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background. He informed the gathering about the consequences of ragging which in his opinion would be devastating for the students. He said that even the honorable supreme court in its order has banned ragging in any form in institutions. Governments have issued stern warning against ragging and proposed ways and means to curb the menace of ragging. He said that ragging is provides a punishment up to 2 years imprisonment or fine which may extend to Rs.10000 or both. In addition, some laws also provide for disqualification or expulsion of student from the educational institution on conviction on the charge of ragging. He hoped that the institution has planned well to prohibit, prevent and eliminate incident of ragging in the campus. He praised the institution authorities for keeping up a good vigil against ragging as no untoward incident of ragging has been reported in the past. He also wished for the same in the future. **ANTI-SEXUAL HARASSEMENT COMMITTEE REPORT- 2021**

Vikrama Simhapuri University Anti –sexual harassment committee was constituted with 9 members including the chairperson Prof.Suja S.Nair. The Committee has conducted two meetings during the academic year 2021. First meeting was done at 12<sup>th</sup> April, 2021 at Social Work Department and second meeting was done on 19<sup>th</sup> August, 2021 at MBA Department and discussed to conduct awareness programmes to students on redress mechanism of Vikrama Simhapuri University. The students Affairs division and wardens of VSU hostels conducted awareness programmes in College Campus and also in Men and Women's hostel premises. VSU setup complaint boxes at Principal office, Administrative wing, Exam section and Men and Women's hostels of VSU. And the management posted anti sexual-harassment rules on college website for student awareness. Measures were taken to educate freshers and final year students if any problem arises talk to the principal or chief warden and if the students face problem in hostel take support of the wardens in hostel by reporting to the care takers and intern they will inform to the wardens immediately or else the students can put their complaint in complaint boxes. The complaint boxes will be open once in a month in the presence of Anti-Sexual Harassment Committee. All the students were educated about Acts which protect them and especially women students how to protect themselves with DISHA Mobile App and its advantages. And also explained to the students community about Disha Act for both Men and Women students due to that men students can have awareness and know what type of punishments they will get if they indulge in sexual harassment activities and its consequences and also it creates awareness among women students how the law protects them. Every year the Anti-Sexual harassment Committee planned programmes for the benefit of women students and Women Employees. Vigilance system for monitoring the movements of students especially new comers in the hostel was arranged and hostel care takers watch the students 24/7 which helps to prevent ragging and harassment in hostels.

The Anti-sexual harassment Committee met two times during the year 2020. First meeting was conducted on 13<sup>th</sup> March, 2020 at Social Work Department at 3.30PM. and second meeting was conducted on 27<sup>th</sup> August, 2020 at Sir CV Raman Seminar Hall at 4 PM. The committee opened the complaint boxes and observed that no complaints received. The committee reviewed the strategies they are using and discussed about the new comers who are facing home sick and depressed. The hostel wardens and care takers counseled the new comers it is noticed that they are coming to the hostel for first time and felt home sick, and counseled the students to visit their homes at weekends, spoke to the parents about the issue and advised them to talk to their daughters daily morning and evening. Care takers are suggested to pay special attention to the girls who are facing home sick and involve them in evening games and sports with their roommates. Advised to the roommates to talk with the girl students and combine them in group discussions and also in games and sports whichever is interested to them. Within a month the girls who faced home sick adjusted to the hostel and College environment and they told that they are confident and will get good marks in term end examinations. With continuous observation and monitoring problems whatever come to the notice of the officials, solve the problems by using peer tutoring technique and counseling techniques. With this way VSU maintaining zero tolerance to harassment and ragging.
