## **BRIEF REPORT ON THE VISIT TO THE UNIVERSITY OF WESTERN AUSTRALIA, PERTH, AUSTRALIA**

*At the outset, I am very much thankful to our Honourable Vice-Chancellor and the Registrar I/c, V.S. University, Nellore for deputing me and sanctioning the financial assistance to discuss with the authorities of the University of Western Australia, Perth on the development of Collaborative Research works on 'Gender Studies' in V.S. University and to organize an International Conference in association with University of Western Australia and V.S. University. Also I thank for permitting me to attend the International Conference at University of Western Australia, Perth.*

### **1. Discussions with Authorities of the University of Western Australia**

We discussed the subject of 'Gender Studies' with **Prof. Kadambot Siddique Hackett, Professor of Agriculture Chair and Director, UN FAO Special Ambassador for the International Year of Pulses 2016**, The UWA Institute of Agriculture, and **Prof. Anu Rammohan, Economics, Business School, Director of International Relations, Faculty of Arts, Business, Law & Education**, the University of Western Australia, who represented UWA to the meeting organized by the Govt. of AP at Hyderabad. They had been very much impressed and appreciated us for discussing the above subject and extended their full support to the development of the collaborative research works in the future. In this connection, we submitted the following two proposals for Collaborative Research works in association with Vikrama Simhapuri University and The University of Western Australia:

- A. Problems of the Girl Children: A Comparative Study of India and Australia

## 2. Attending the International Conference on 'Women in Asia'

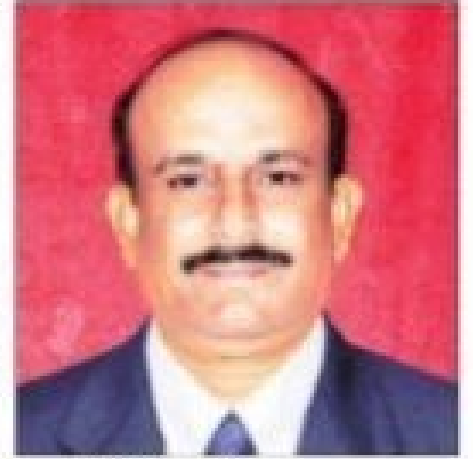
