ORDER

Subject :- Financial assistance for the research project entitled "In search of Leptin inhibitors from fungal endophytes(LIFE)s for the development of novel immunomodulating lead compounds" by **Dr. K.Chandra Mouli**, Department of Biotechnology, College of Science & Technology, **Vikrama Simhapuri University**, Nellore-524001, Andhra Pradesh.

In partial modification of SERB sanction order no. SB/YS/LS-309/2013 dated 30 June, 2014, Sanction of SERB is here by accorded to the additional provision of Rs. 6,66,452/- (Rs. Six Lakh Sixty Six Thousand Four Hundred Fifty Two Only) under 'Manpower(PI Fellowship)' due to the enhancement in the fellowship amount from Rs.35,000/- to Rs. 55,000/- per month w.e.f. 1st October, 2014, thereby increasing the total cost from Rs. 24,40,000/- (Rs. Twenty Four Lakh Forty Thousand Only) to Rs. 31,06,452/- (Rs. Thirty One Lakh Six Thousand Four Hundred Fifty Two Only) for the implementation of above mentioned project. 7. The Sanction has been issued with the approval of the competent authority under delegated powers and vide Diary No. **SERB/F/1145/ 2015-16 dated 9.06.2015.**

9. The Institute will furnish to the SERB, Utilization Certificate and an audited Statement of Account pertaining to the grant immediately after the end of each financial year.

10. The Institute will maintain separate audited accounts for the Project. It is found expedient to keep a part or whole of the grant in a bank account earning interest. The interest earned should be reported to the SERB. The interest thus earned will be treated as a credit to the institute to be adjusted towards further installment of the grant.


