RESOLUTIONS

The VSU Research Committee Meeting held on 13.07.2022 at 3.00 PM discussed various issues relating to Research activity in the V. S. University and resolved the following:-

- If the Maximum Period after registration is completed, that can be shown as vacant seat after DRC resolutions.
- Two research articles should be published before submission of the thesis. For science
 Scholars one article should be published in SCI Journals and the other in Referred or Peer
 Reviewed Journal. For Arts, Commerce & Management, one article should be published in
 UGC care list and the other in Peer Reviewed Journals.
- 3. The Research Scholar should be the first author in 2 articles / publications.
- Articles should be published from the thesis and certified by the DRC and minutes should be communicated to the Controller of Examinations through Dean, R&D.
- Executive quota seats should be filled based on the interest of the candidate. At a time not more than one candidate will be allotted to one Research Supervisor.
- 6. Ph.D candidates shall be allotted to faculty working in affiliated colleges if they have eligibility of guideship and if the colleges have established Research Centre & if the said college has concerned PG programme for the last 2 years. All these conditions mentioned above will be applied only when the Research Supervisors in the concerned subjects are not available in the University departments.
- If no Research Supervisor fulfills the above conditions from the affiliated colleges seats
 may be allotted to the Research Supervisor in the concerned Departments of the University
 beyond the limit of seats.
- 8. No more guideship for the faculty working in affiliated colleges from 2022-23.
- Application may be sent to Dean, R &D to verify the eligibility and to issue proceedings to Dr. G. Padma Priya, Lecturer in Telugu, PRR & VS Govt. College, Vidavalur.

- 10. For the candidates who have completed their Maximum period with extensions, the permission may be granted to submit their thesis as per the UGC Public notice before December 31°, 2022. This may be considered as one time settlement for long pending candidates who ever have not yet submitted thesis. After approval this information may be placed in University Website (R & D Portal).
- 11. If at least 3 names matched, the revised panel of Examiners should be submitted by both Research Supervisor & BOS Chairperson while submitting the panel.
- 12. The Status of FRGS Grants should be reviewed and report to be submitted by Dean, -R & D to the authorities.
