ORDER:

The District Collector, Sri Potti Sriramulu Nellore in his letters 1st and 2nd read above has stated that the Chairman, A.P. State Council of Higher Education, Hyderabad in his letter dated 10.04.2008 has requested the District Collector, SPS Nellore for allotment of land for construction of Vikrama Simhapuri University buildings. Accordingly suitable Government land and private patta land has been identified in Kakatur (V) of Venkatachalam (M), Sri Potti Sriramulu Nellore District.

2. The District Collector, Sri Potti Sriramulu Nellore in his letter 1st read above has submitted proposal to the Government in Higher Education Department for payment of ex-gratia to the (40) encroachers of Government land to an extent of Ac. 65.26 cts., out of a total extent of Ac. 83.31 cts. (i.e., Ac.4.49 cts. vacant land; Ac.13.56 cts. is Kunta land; and Ac. 65.26 cts. occupied by the encroachers) in Sy.Nos.435, 439, 441 etc., of Kakatur (V), Venkatachalam (M), Sri Potti Sriramulu Nellore District for establishment of Vikrama Simhapuri University on payment of 50% of market value @ Rs.6-00 lakh per acre in terms of G.O.Ms.No.243, Revenue (LA) Department, dated 27.3.2010.

3. The District Collector, Sri Potti Sriramulu Nellore in his letter 2nd read above has submitted proposal to the Special Chief Secretary & Chief Commissioner of Land Administration, A.P., Hyderabad for alienation of land to an extent of Ac.83.31 cts. in Sy.Nos.435, 439, 441 etc., of Kakatur Village, Venkatachalam Mandal in favour of the Vice-Chancellor, Vikrama Simhapuri University, Nellore for establishment of Vikrama Simhapuri University buildings.

4. The District Collector, Sri Potti Sriramulu Nellore has further stated that the entire Government land to an extent of Ac 83-31 cts. situated in Sy.Nos.435, 439, 441 etc., of Kakatur Village, Venkatachalam Mandal was handed over to the Vice-Chancellor, Vikrama Simhapuri University, Nellore for construction of Vikrama Simhapuri University buildings in two spells on 26.8.2010 and 13.10.2010 respectively. The land was lying waste on ground at the time of handing over the possession. He has requested the Government in Higher Education Department, to release an amount of Rs.2,49,93,000/- (i.e., 50% of the market value as per G.O.Ms.No.243, Revenue (LA) Department, dated 27.03.2010) for payment of ex-gratia payable to the encroachers to an extent of Ac.83.31 cts. on payment of 50% of the market value of Rs.6-00 lakh per acre.

5. The Special Chief Secretary & Chief Commissioner of Land Administration, Andhra Pradesh, Hyderabad in the letter 3rd read above, while enclosing reports of the District Collector, Sri Potti Sriramulu Nellore has requested the Government to issue necessary instructions/orders regarding payment of ex-gratia payable to the encroachers of the Government land to an extent of Ac.83-31 cts. in Sy.No.435 etc., in Kakatur Village of Venkatachalam Mandal, SPS Nellore as recommended by the District Collector, Sri Potti Sriramulu Nellore, as a special case.

6. Government, after careful examination of the proposal of the District Collector, Sri Potti Sriramulu Nellore and the Special Chief Secretary & Chief Commissioner of Land Administration, Andhra Pradesh, Hyderabad hereby order for payment of ex-gratia to the (40) encroachers of Government land to an extent of Ac.65.26 cts., out of a total extent of Ac.83.31 cts. (i.e., Ac.4.49 cts. vacant land; Ac.13.56 cts. is Kunta land; and Ac. 65.26 cts. occupied by the encroachers) in Sy. Nos. 435, 439, 441 etc., of Kakatur Village, Venkatachalam Mandal, Sri Potti Sriramulu Nellore District in favour of the Vice-Chancellor, Vikrama Simhapuri University for establishment of Vikrama Simhapuri University buildings on payment of 50% of the market value of Rs.6-00 lakh (Rupees six lakh only) per acre, in terms of G.O.Ms.No.243, Revenue (LA) Department, dated 27.3.2010, as a special case.

7. The Special Chief Secretary & Chief Commissioner of Land Administration, Andhra Pradesh, Hyderabad and the District Collector, Sri Potti Sriramulu Nellore shall take necessary action accordingly.

ORDER:

In the reference 1st read above, Government has advised the Vice Chancellors of the newly formed Universities in the State, to exercise the powers as per the proviso of the A.P.Universities Act, 1991 to affiliate the colleges falling under their jurisdiction from the academic year 2010-11 and take necessary action to provide the minimum facilities, to provide the affiliation work.

2. In the reference 2nd read above, the Vice Chancellor, Vikrama Simhapuri University, SPSR Nellore has requested to take immediate steps to bring the S.V.University Post Graduate Centre, Kavali under the control of Vikrama Simhapuri University, Nellore. He has further requested that the faculty, non-teaching staff positions attached to the Centre, the U.G.C. and other programmes and Plan allocations earmarked to it, seed money, fee accumulations and all other assets including the relevant budgetary provisions may also be transferred to Vikrama Simhapuri University, Nellore.

3. In the reference 3rd read above, the Secretary, A.P.State Council of Higher Education, Hyderabad has stated that the A.P.State Council of Higher Education is of the view that the transfer of Sri Venkateswara University Post Graduate Centre, Kavali which is presently under the administrative control of Sri Venkateswara University, Tirupati along with assets and infrastructure, posts, corpus fund, budget as on the date of issuing the order to Vikrama Simhapuri University, Nellore deserves consideration and hence, requested the Government to issue necessary orders in the matter.

4. The Section 6-A(1) of Act 4 of A.P. Universities Act, 1991 (as amended in Act No.19 of 1993), read as follows:-

“Notwithstanding anything in this Act, every college or institution which was affiliated to or associated with or recognized or maintained by any of the Universities in the Schedule at the commencement of this act and which as on such commencement gone into the University area of a different University shall on and from the commencement of the Andhra Pradesh Universities (Second Amendment) Act, 1993, stand transferred to the University in whose area such college or institution is located and shall hereafter be deemed to have been affiliated to or associated with or recognized by such University to which it is transferred and shall be maintained by such University”.

5. In view of the facts mentioned above, the Postgraduate Centre, at Kavali automatically stand transferred to Vikrama Simhapuri University, SPSR Nellore District. Accordingly, Government, after careful examination of the matter and in exercise of the powers conferred in sections 50, 56 of A.P.Universities Act, 1991 and the provision provided in section 6-A of the Andhra Pradesh Universities Act, 1991 (Act 4 of 1991) as amended in Act No.19 of 1993, hereby transfer the Post Graduate Centre, Kavali, along with staff and assets from the administrative control of Sri Venkateswara University, Tirupati to newly established Vikrama Simhapuri University, Sri Potti Sreeramulu Nellore District, henceforth.

6. The Staff working in Post Graduate Centre, Kavali shall be given an option either to remain in the parent University or go into the service of new University i.e. Vikrama Simhapuri University in accordance with section 6-A(2) of A.P.Universities Act, 1991 (Act 4 of 1991) and amended in Act 19 of 1993.

7. The Registrars of the Vikrama Simhapuri University, SPSR Nellore District and Sri Venkateswara University, Tirupati are requested to take necessary action in the matter accordingly.
