### <u>ORDER</u>

Government have decided to establish six (6) new State Universities at Karimnagar, Mahaboobnagar, Kurnool, Nellore, Srikakulam and Krishna Districts by upgrading the present Post Graduate centres, wherever available, with a view to augment the educational facilities in the said Districts and to cater to the educational needs of the people of the above six districts.

**2.** The High Power Committee has visited the above six Districts and identified the appropriate space and location for starting of the said new Universities, and submitted their recommendations to the Government.

**3.** Government after careful examination, have accepted the recommendations of the High Power Committee for setting up of six (6) new State Universities at Karimnagar, Mahaboobnagar, Kurnool, Nellore, Srikakulam and Krishna Districts from the academic year 2008-2009 and decided to amend the Schedule to the Andhra Pradesh Universities Act, 1991.

**4.** Accordingly, the following notifications will be published in the Extraordinary issue of the Andhra Pradesh Gazette.

### **NOTIFICATION-1**

In exercise of the powers conferred under sub-section (1) of section 3 of the Andhra Pradesh Universities Act, 1991(Act No.4 of 1991), Government hereby establish six (6) new State Universities commencing from the Academic year 2008-2009 with the names, area of operation and headquarters as specified below:-

### ORDER:

In the reference 1<sup>st</sup> read above, Government has advised the Vice Chancellors of the newly formed Universities in the State, to exercise the powers as per the proviso of the A.P.Universities Act, 1991 to affiliate the colleges falling under their jurisdiction from the academic year 2010-11 and take necessary action to provide the minimum facilities, to provide the affiliation work.

2. In the reference 2<sup>nd</sup> read above, the Vice Chancellor, Vikrama Simhapuri University, SPSR Nellore has requested to take immediate steps to bring the S.V.University Post Graduate Centre, Kavali under the control of Vikrama Simhapuri University, Nellore. He has further requested that the faculty, nonteaching staff positions attached to the Centre, the U.G.C. and other programmes and Plan allocations earmarked to it, seed money, fee accumulations and all other assets including the relevant budgetary provisions may also be transferred to Vikrama Simhapuri University, Nellore.

3. In the reference 3<sup>rd</sup> read above, the Secretary, A.P.State Council of Higher Education, Hyderabad has stated that the A.P.State Council of Higher Education is of the view that the transfer of Sri Venkateswara University Post Graduate Centre, Kavali which is presently under the administrative control of Sri Venkateswara University, Tirupati along with assets and infrastructure, posts, corpus fund, budget as on the date of issuing the order to Vikrama Simhapuri University, Nellore deserves consideration and hence, requested the Government to issue necessary orders in the matter.

4. The Section 6-A(1) of Act 4 of A.P. Universities Act, 1991 (as amended in Act No.19 of 1993), read as follows:-

"Notwithstanding anything in this Act, every college or institution which was affiliated to or associated with or recognized or maintained by any of the Universities in the Schedule at the commencement of this act and which as on such commencement gone into the University area of a different University shall on and from the commencement of the Andhra Pradesh Universities (Second Amendment) Act, 1993, stand transferred to the University in whose area such college or institution is located and shall hereafter be deemed to have been affiliated to or associated with or recognized by such University to which it is transferred and shall be maintained by such University".

5. In view of the facts mentioned above, the Postgraduate Centre, at Kavali automatically stand transferred to Vikrama Simhapuri University, SPSR Nellore District. Accordingly, Government, after careful examination of the matter and in exercise of the powers conferred in sections 50, 56 of A.P.Universities Act, 1991 and the provision provided in section 6-A of the Andhra Pradesh Universities Act, 1991 (Act 4 of 1991) as amended in Act No.19 of 1993, hereby transfer the Post Graduate Centre, Kavali, along with staff and assets from the administrative control of Sri Venkateswara University, Tirupati to newly established Vikrama Simhapuri University, Sri Potti Sreeramulu Nellore District, henceforth.

6. The Staff working in Post Graduate Centre, Kavali shall be given an option either to remain in the parent University or go into the service of new University i.e. Vikrama Simhapuri University in accordance with section 6-A(2) of A.P.Universities Act, 1991 (Act 4 of 1991) and amended in Act 19 of 1993.

7. The Registrars of the Vikrama Simhapuri University, SPSR Nellore District and Sri Venkateswara University, Tirupati are requested to take necessary action in the matter accordingly.
