**ORDER:**

The Ministry of Statistics & Programme Implementation, Govt. of India, New Delhi in the reference 1<sup>st</sup> cited have been communicated certain guidelines for sanction and implementation of developmental works under MPLADS.

In the reference 2<sup>nd</sup> cited, the District Collector, Tirupati has informed that Dr.Maddila Gurumoorthy, Hon'ble MP[LS], Tirupati has proposed the following work with an estimated cost and **MP Share of Rs.23.00 Lakhs** and requested the District Collector, SPS Nellore to accord administrative sanction from MPLADS funds for the year 2021-22 of 17<sup>th</sup> Loksabha.

After scrutiny of the proposals with reference to the guidelines issued by the Government of India under MPLADS, administrative sanction is hereby accorded for the above work with an estimated cost and MP Share of Rs.23.00 Lakhs under MPLADS for the year 2021-22 in respect of Tirupati Lok Sabha Constituency to the Executive Engineer, Panchayat Raj Institution, Nellore, for execution.

The Executing Agency is requested to execute the work as per MPLADS guidelines and subject to the conditions as follows.

- 1. The Executing Agencies should submit technically sanctioned estimates to the Chief Planning Officer, Nellore for according financial sanction and release of funds.**
- 2. The executing agencies are requested not to ground the work until receipt of financial sanction from the District Collector, Nellore.**
- 3. The executing agency should follow the established work scrutiny, technical, work estimation, tendering and administrative procedure of the State Government in the matter of work execution, and shall be responsible for timely and effective implementation of such works.**
4. The executing agency should execute the work as per MPLADS Guidelines.
5. The executing Agency should confirm that the work has not been previously sanctioned under any other scheme.
6. The executing agency should obtain undertaking from the user agency before execution of the work sanctioned and commit them for operation, upkeep and maintenance of the asset created with the MPLADS funds.
7. The executing agency should obtain technical sanction from the competent authority before grounding the work and send to the District Collector for release of 1<sup>st</sup> installment.



8. The executing agency has to maintain separate cashbook and bank account for each MP in nationalized banks only.
9. The executing agency should follow these guidelines, as this is a one time grant sanctioned by Government of India and they have to complete the work as per specifications within the scheduled time.
10. The executing agency should complete the work within a year from the date of issue of administrative sanction.
11. The executing agency shall not levy administrative, centage charges, salary of any person, travel cost etc. in respect of MPLADS works.
12. The executing agency should not pay any advance or maintenance charges from MPLADS funds.
13. The executing agency should install permanent plaque (Stone/ Metal) exhibiting an "inscription" as the work is taken up under MPLADS programme and Name of the M.P. in regional language with time and date of completion.
14. The executing agency should submit the work completion report in the prescribed proforma **along with the asset handed over certificate to user agency must produce for final payment.**
15. The executing agency should submit the progress report to the Chief Planning Officer, Nellore and update before 5<sup>th</sup> of every month.
16. The executing agency should submit the photographs before starting and after completion of the work with same topographical identifications besides visible plaque and send the same to the District Collector for release of final installment.
17. The executing agency should refund the savings with interest accrued on the each completed work within 30 days after completion of the work.
18. The executing agency should maintain asset register with the names of user agencies.
19. The executing agency is informed that the Right to Information Act, 2005 and the Rules framed there under are applicable to MPLADS.
20. The asset should not be named after any name of the individuals.

**The Executing Agency is further informed that all maintenance works of any type are prohibited as per MPLADS Guidelines.**

**The Executing Agency is also requested not to take up the work unless funds received from the District Collector, Tirupati District and released by the District Collector, SPS Nellore District to the concerned.**

**The District Collector, Tirupati District is requested to release funds to take up the above work at the earliest.**

**The Executing Agency is also informed that the financial sanction will be accorded only soon after the receipt of the detailed estimate and technical sanction for the above work.**

The executing agency should follow and fulfil the above guidelines and act accordingly.
