MEMORANDUM OF UNDERSTANDING

BETWEEN

KVR SCIENTIFIC SERVICES, SPSR NELLORE, A.P., INDIA

AND

VIKRAMA SIMHAPURI UNIVERSITY, SPSR NELLORE, A.P., INDIA

1. Preamble

This Memorandum of Understanding (hereinafter called "MOU") is entered between the KVR Scientific Services (hereafter referred to as KVRSS Group) registered address at 2-21A, Scientist's Home, KambhamVari Street, Duttalur, SPSR Nellore-524222, Andhra Pradesh, India and the Vikrama Simhapuri University (hereinafter referred to as "VSU" or "PARTY" or "UNIVERSITY" or "INSTITUTION"), registered address at Kakutur, Nellore, Andhra Pradesh, India, collectively referred to (hereinafter) as the "PARTIES".

2. Objective

The PARTIES recognize the benefits to be derived from increased collaboration, cooperation and interaction for further promotion and understanding of the research activities, publishing of scientific papers and/or books / book chapters and indexing, assistance in support of other academic activities such as scientific conferences, eLearning system and journal management, assistance in the development of technology and its maintenance, live streaming of events, providing necessary stationary like brochures, booklets, etc and other activities as per the discussion and understanding.

3. Purpose

The purpose of this MOU is to provide the Online Classes Platform (Microsoft Teams) and to implement previously mentioned academic and research activities for the VSU.

4. Scope

This MOU sets forth the intentions of both PARTIES for increased collaboration, and cooperation for the Online Classes Platform (Microsoft Teams). If the PARTIES later agree to undertake specific joint projects with the legally binding obligations, PARTIES will develop separate written agreements for such projects, setting out each Party's contributions, deliverables and budgets.

5. Responsibilities of KVRSS Group

5.1. Responsible for managing the Microsoft Teams.

- 5.2. Responsible to create IDs for the faculty, students and other computational support (as per the requirement of VSU).
- 5.3. Providing technical support for the VSU on request through the document.

6. Responsibilities of VSU

- 6.1. Responsible to provide the required data for the creation of IDs.
- 6.2. Responsible to appoint an institutional technical support person/team.
- 6.3. Implementation of the Microsoft Teams for online classes.

7. Pricing

7.1. Microsoft Teams

KVRSS Group is providing Microsoft Teams for free of cost for the VSU. However, other computational facilities will be provided for the payment.

7.2. Server Management

VSU has to pay external server management charges of Rs. 20000/- plus 18% GST per academic year. Total price (including GST) to be paid by the VSU is Rs. 23,600/- per academic year.

8. Features

- 8.1. The requested feature by the VSU is Microsoft Teams.
- 8.2. KVRSS Group has also provided additional features and those details can be found at www.office.com.

9. General Clauses

- 9.1. If circumstances warrant the discontinuance of the usage of services by the VSU (or) KVRSS Group decides to discontinue its services to the VSU, such discontinuance will be considered after mutual discussion of both PARTIES. The decision to discontinue from this MoU will be implemented with giving three months prior notice by either side and upon mutual discussion.
- 9.2. This MOU shall be effective as and when executed by or on behalf of both PARTIES.

10. General Provisions

- 9.1. Both the PARTIES have full power and authority to enter into this MoU, take any action, and execute any documents required by the terms hereof; and that this MoU, entered has been duly and validly executed and delivered, and is a legal, valid, and binding obligation of, enforceable in accordance with the terms hereof; and that the executants of this MoU are duly empowered and authorized to execute this MoU and to perform all its obligations in accordance with the terms herein.
- 9.2. This agreement shall not be binding for any other agreement(s) for either party. PARTIES shall be free and independent to carry-on other services and training besides that covered under the scope of this agreement.
- 9.3. The KVRSS Group & the VSU shall perform their duties in strict compliance with all the applicable laws in India along with the rules and regulations of duly constituted Government, authorities in India

and shall obtain all the licenses, restrictions or other approvals, if any, required by the law in India in connection with the services to be rendered hereunder.

10. Terms and Conditions

- 10.1. In case the products / projects owned by the KVRSS Group, VSU should comply with the terms and conditions of respective products.
- 10.2. VSU should obey with the terms and conditions of that product or project owned by other companies/organizations like Microsoft.
- 10.3. This Memorandum may be modified with supplemental written agreements signed by the parties and can be terminated in writing, in whole or in part, by consensus of the PARTIES.

11. Duration

This MOU shall be effective for 5 years from the date of final signature. It may be modified or terminated by mutual written agreement by the PARTIES. This MOU may be terminated by either party upon three months advance written notice.

12.Communication

Any notice or request given or made by one party to the other under this MOU shall be in writing in the language of English and shall be addressed to the party's Registrar as is designated in writing hereinafter:




