

# EMPLOYMENT AGREEMENT

THIS AGREEMENT OF EMPLOYMENT entered into this 01<sup>st</sup> day of January 2020 (for the period commencing from 01<sup>st</sup> day of January to 31<sup>th</sup> December 2020 ) between Uni-President Vietnam Co. Ltd., (Hereinafter called as Employer Company), having engaged in the business of Manufacturing and selling Fish and Prawn Feeds and exporting to India.

### AND

P. Nitya Jeevan Kumar, S/o Sundar Rao Residing at Yallareddy peta Village, Rachayapeta Post, Gopavaram Mandal, YSR Kadapa District, Andhra Pradesh, Pin code – 516233.

Whereas the Employer Company offered a Job to Mr. Nitya Jeevan Kumar as a Sales and Technical Manager of Nellore Area, Andhra Pradesh and the said Employee agreed and accepted to act as such.

AND whereas pursuant to the said acceptance by the Employee Mr. Nitya Jeevan Kumar, the Employer Company confirms the appointment of said Employee on the terms and conditions as detailed here under;

- 1. The Employee Mr. Nitya Jeevan Kumar shall act as Sales and Technical Manager for Nellore area, Andhra Pradesh in the Employer Company's Head Office in Vietnam, and he shall undertake the assignments within Andhra Pradesh as and when required for which he will be eligible for travelling and allowances.
- 2. The Employee shall report to Director-Aquatic Business Division- India to take instructions for day-to-day work assignments.

- 3. The employee must send the report to Vietnam office before 23:00 PM Sunday weekly, the Employer will deduct USD 15 per time in the salary if the report is be sent after deadline
- 4. The Employee will be paid a consolidated salary of USD 1135 per month (Inclusive of Medical and Accidental Insurance, Dearness allowances -except accommodation allowance outside his territory and oil allowance). The salary will be remitted from Vietnam to the Employee's bank account before 10<sup>th</sup> of every succeeding month.
- 5. The Employee must purchase Medical and Accidental Insurance by themselves, and need to send the copy of the insurance certificate to the Employer. If Employee will get any illness or met with any accidents, Employer will not be responsible.
- 6. The Employer will offer 13<sup>th</sup> salary in the December 2020 after finishing the full working year
- 7. The Employee shall be entitled for the 12 days Sick Leave and 14 days for India Holiday annually. All leaves left can't be carried over to next year.
- 8. Employee's appointment is subject to verification of particulars mentioned in the application. In case those particulars are found unsatisfactory or false, Employee's service is liable for termination without any reason or notice thereof at any time.
- 9. The Employee shall work under the supervision of Director-Aquatic Business Division- India Operation nominated or to be nominated by the Employer Company and shall work diligently and faithfully carry out the instructions of his superiors in connection with the work assigned to the best of his abilities and to ensure the interest of the Employer Company.
- 10. The Employee shall not engage in promoting or dealing or otherwise being concerned in the sale of any other Company's fish and prawn feed, aqua products, aqua healthy products and aerators, competing with or in the same or similar class as that of Employer Company Brands.

- 11. The Employee shall not fix the prices for the products other than fixed by the Employer Company and the Employee shall not deal with cash transaction on behalf of the Employer Company in any manner. The Employee should not involve any aqua products transaction or cash transaction or selling the feed among dealers. The employer will file the Employee if the employee concerns
- 12. The Employee shall not seek membership of any local or public bodies without prior written permission from the Employer Company.
- 13. The Employee shall not give out Employer Company's information to any one during the period of his service and 3 years after termination of service by word of mouth or otherwise, particulars or details of his process, technical know-how, security arrangements, development plan, pricing structure and administrative and / or organizational matters of confidential / secret nature.
- 14. In the course of employment if the necessity arises the Employer Company will entrust necessary equipment's, articles, computer and other ancillaries to the employee in order to facilitate the course of employment and the same have to be retained as the property of Employer Company till the time and protected the particulars, data and details of the Employer Company business, etc which are to be handled by the employee to the utmost care and responsibility in the light of the other terms and conditions enumerated in this agreement. Whereas the employee is entrusted with any of the property and trade secret it should be appropriately returned to the Employer Company in the event of resignation, termination or in the event of concluding the contract without any tampering or damaging the property and the details entrusted to the employee.
- 15.In the event of violation of any of the terms and conditions in this agreement the employee is liable to be penalized on the liquidated damage apart from also liable to be prosecuted for the criminal offences wherever it is applicable and also the employee is liable to compensate to the extent of the damages caused or loss of business to the Employer Company due to such conduct in contrary to the terms and conditions agreed upon herein.

- 16. The Employee shall keep confidential all the information and material provided by the Employer Company or by its clients or contractors concerning their affairs.
- 17. The Employee shall be governed by the service, rules and regulations including the conduct, discipline, administrative orders and any such others rules/ orders of the Employer Company that may be in force from time to time.
- 18. The Employee shall intimate in writing to the Management if there is any change of address, family status or educational background within 7 days of such change, as the case may be.
- 19. The designation assigned to the Employee is subject to changes depending upon the assignments decided by the Employer Company from time to time or any other organizational eventuality.
- 20. The salary and other terms of this appointment/agreement are to be kept confidentially.
- 21. The Employer Company reserves the right to terminate this agreement subsequent to confirmation by giving notice of one month or payment in lieu thereof. Similarly, the Employee is at liberty to resign from the services of the Employer Company on giving one month notice or payment thereof.
