Indian banking structure is very different from that of other countries. Banking is considered as the backbone of the country. Finance is the vital element for a country's trade, commerce and industry.

India is not new to demonetisation because it has implemented first currency ban in 1946, second time currency ban in 1978 and third time currency demonetised in 2016.

Demonetisation had a wide impact. It has affected the withdrawal of nearly 86% of the currency in circulation in India. The monetary action of banning Rs 1000 and Rs 500 notes produced several direct and indirect effects on transaction behaviour as well as on illegal money. Demonetisation has provided the invaluable service of giving mass awareness campaign against black money. It has promoted the digitalization of transactions and digital payments.

The Central Government states that the demonetisation policy is trying to make India corruption free; to curb black money; to control escalating price rise; to stop funds flow to illegal activity; to make people accountable for every rupee they have and pay income tax return. Finally, it is trying to make a cashless society and create a Digital India.

Demonetisation has resulted in a rise in deposit growth at a time when banks have reduced interest rates on term deposits. According to the RBI, deposits rose from Rs 12.7 lakh crore to Rs 105 lakh crore when compared to the last year. Govt orders shuttering of 1 lakh dodgy companies in 48 hours, PM signals crackdown on tax evaders. Government of India has become successful to some extent. Demonetisation has created so many hurdles for the citizens of India.

Therefore, there are many issues that need to be discussed on the new monetary policy of India in the form of Demonetisation.

Theme of the Conference

The demonetisation of the 500 rupee note and the 1,000 rupee note; the two highest currency denominations available in India had hit the economy hard in the short-term. The service sector, which dominates economic activity and involves a sizable chunk of cash transactions had the hardest hit.

The government had called this situation bringing of "short-term pain for long-term gain". Demonetisation has affected the common people and created panic among the poor and common masses. But the long-term effects of demonetisation will surely bring the fruits to India. This will change the history of India and bring a digital transaction revolution to the country.

The demonetisation relates to replacing 86% of Indian currency; the growth of Indian economy; the development of every sector and the growth of banking sector.

Summary Report on the Proceedings of the National Conference on "Demonetisation in India Impact and Prospects" held on 28-29th December 2017

A two-day National Conference on the "Demonetisation in India- Impact and Prospects" was organized in the Department of Commerce, V.S. University P.G. Centre, Kavali, Nellore District Andhra Pradesh during 28-29th December 2017, under the Convernership of Dr.Ch.Srinivasa Rao, Head & Associate Professor of Commerce.

Inaugural Function started with welcome and invocation at 10.30 a.m. followed by V.S. University Anthem.

The Conference was inaugurated through lightening the lamp by the chief guest Prof. V. Veeraiah, Vice-chancellor of V.S. University Nellore. He inaugurated the seminar proceedings "Demonetisation Impact and Prospects" which was published with ISBN with 85 articles by different researchers as a part of Conference. In his inaugural address Prof. V. Veeraiah explained about the impact and prospects of Demonetisation in India. He also narrated his personal experiences and problems faced by him at the time of demonetisation particularly in November 2016. He also explained the benefits of demonetisation to the nation in near future. He explained that the digitalization is useful to the nation as well as development of banking system in India. He also explained contemporary burning issue, advantages and disadvantages of demonetisation and also he told technology usage should not become a threat for others and sudden reforms always face resistance. He says that it should be analysed after a long period and then only success rate failure rate can be identified

In his President's opening remarks Prof.M.Chandraiah, Registrar of Vikrama Simhapuri University explained in detail benefits of demonetisation in future and need to eradication of black money. He expressed his happiness over conducting this seminar in his own department, having 44 years of history. He said because of demonetisation black money recover is 0.01% only. He narrate the problems and advantages from demonetisation.

Prof.S.Durga Rao Dept. of Management, S.V.University who participated as distinguished guest in the conference illustrated how the Demonetisation influencing different

sectors in India. He explained about the gains and losses of demonetisation. He discussed about 3 issues like black money, counterfeit fake currency and digitalisation besides failures of the demonetisation.

In his keynote address, Prof. K. Ramakrishnaiah Dean CDC & Professor of Commerce, S.V.University, Tirupati covered all the aspects of Demonetisation. He explained about ban on old notes; introducing new notes in the middle; common man struggle; black money, fack money, corruption etc. he narrate the opinions of Amarthya Sen, Manmohan Singh and Arun Soury comments and demonetisation negative effect which will paralise the unorganised sectors agriculture small scale industry, common and poor people. He also narrates Arun Gaitly, Arvind Hirmony opinions positive reactions of demonetisation and he concludes initially there may be some difficulty but in long run it will prove fruitful.

Prof.P.R.Sivasankar, Dept. of Commerce V.S.U. P.G. Centre, Kavali explained about resistance regarding reforms, short term-medium term and long term effects and finally concludes that demonetisation in long term will prove itself as a success and put forth the profile of the dept.

Prof.P. Venkatarao, Special Officer V.S.U. P.G. Centre, Kavali put forth the profile of PG centre besides the conference importance.

The conference convener Dr.Ch.Srinivasa Rao presented the theme, objectives of the conference and the reason to select this seminar topic. After honouring the guests the inaugural function ended with vote of thanks at 1.00 p.m.

There were four technical sessions on the theme of the conference devoted to discuss Historical Perspectives of demonetisation in India & Abroad; Sectoral Implications of demonetisation; Socio-Cultural and Economic Implications of demonetisation; Eradication of Corruption and Black Money by demonetisation; Impact of demonetisation on the Indian Economy and society; Demonetisation and Politics; Emerging trends in Digitization; Successes and failures of Demonetisation and Demonetisation issues and challenges.

On the 1st day two technical sessions were completed. After the Inaugural session it started at 2.00 p.m. (1p.m to 2p.m lunch break) and ended by 5.30 p.m.

<u>First technical session</u> was chaired by Prof.S.Durga Rao, Dept.of Management, S.V.University, Tirupati. Dr.K.Rama Prasad, Senior Lecturer, Govt. Degree College Kovvur Nellore district was the discussant and Dr.Tyagaraju of V.S.U Nellore was the rapporteur. In this session, 18 papers were presented by the delegates from Andhra University, Nagarjuna University and Yogivemana, Rayalaseema Universities areas etc.

The second session was chaired by Prof.K.Rama Krishna Rao, dean CDC & Dept of Commerce, S.V. University, Tirupati. Dr.P.M.Siva Prakash of ISO Degree College, Tarnaka

Hyderabad was the discussant and Dr.S.Venkata Subba Reddy of Yogi Vemana University Kadapa was the repporteur of the session. 17 papers were presented in the session on the Demonstration and its Impact. The delegates were from Kakatiya University, S.V. University and Nagarjuna University areas and from various Degree Colleges.

The total papers presented on the first day were 35 among which 8 papers are based on primary data and remaining on theoretical information.

On the second day, 2 technical sessions were organized between 10.00 a.m and 2.00 p.m. The first technical session was chaired by Prof. J.Katyayani, Dept. of Business Management, Sri Padmavathi Mahila University, Tirupati. K.Maheswara Gupta of Sri Ramakrishna Degree College Kurnool and Dr.M.Venkata Subbaih, Govt. Degree College Rapur acted as discussant and the rapporteur respectively. 16 papers were presented in this session and the delegates are from Gulbarga, Brehampur University, Yogi Vemana, Sri Venkateswara and Vikrama Simhapuri University areas.

Prof B.Sudhir Director, Directorate of Admissions S.V.University, Tirupati chaired the second session where B.Venkateswa Rao, Berhampur Odisha acted as discussant. Dr.K.Ekambaram VSUPG Centre, Kavali was the rapporteur. 18 papers were presented in the session on the Demonetisation and its prospects and the delegates have come from VSU Nellore and SVU, Tirupati and local degree colleges.

The total papers of second day were 34. 10 papers were based on primary data and remaining 22 papers were on theoretical base. The total no. of papers presented during these two day seminar is 69.

During the sessions, all the chairmen have delivered useful and relevant messages and conducted the sessions in an effective manner.

After lunch break the valedictory function started at 3.00 p.m. with welcome and invocation by M.Com students. In the President's opening remarks, Prof P.Venkata Rao invocation by M.Com students. In the President's opening remarks, Prof P.Venkata Rao Special officer, VSU PG Centre, explained about the history of demonetisation, move towards a cashless economic frame work, short-term and medium-term impacts of towards a cashless economic frame work, short-term and medium-term impacts of demonetisation on different sectors of society like real estate, travelling, business, IT Industry.

The Chief Guest Sri K.S.P.V. Ramana Murthy, DGM Andhra Bank, Ongole reminded that countries benefit and necessity of fight with black terror fake money. He says demonetisation may create havoc but benefits in long run. The demonetisation is a sudden plan and sudden implementation of Govt. through demonetisation against black money so one should not creatise without going into the deep core of the reform and he appreciated the Conference convener in selecting the suitable area and useful topic for conference.

Prof.P.R.Sivasankar, Dean, Faculty of Commerce and Management V.S.U. Distinguished Guest in his speech has given a lot of information, analyzed the demonetisation and increase of GDP growth in demonetisation and he opinioned demonetisation should be a success in implementation.

Prof.B.Sudhir, Dean, Directorate of Admissions S.V.University guest of honour says demonetisation is as short term pains for long term gains and useful for cashless society and digitalization in India.
