Both VSU and HCS shall also be collectively referred to as the "Parties" and individually as Party".

#### SCOPE OF MoU

The scope of MoU is to define a mechanism to promote internship programmes, community service projects and skill enhancement courses for the undergraduate, and postgraduate students. Further, to support research scholars and faculty working in the areas of health sector. Moreover, this MoU acts as a platform to start value added courses related to health sector.

## **OBJECTIVES**

- to jointly organize certificate programmes to undergraduate and postgraduate students in health sectors
- to organize value added courses to the students
- to support research scholars and faculty working in the area of health sector
- to act as a bridge between the health sector and the VSU
- to exchange information on research and educational programmes
- to jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein
- to jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty to participate therein
- to provide internships/research projects to the students at the PG and doctoral levels

## RESEARCH AND DEVELOPMENT

VSU and HCS agree to help identify and invite faculty members from the other institution to participate in research or development programmes. The terms and conditions for such participation will be worked out by mutual agreement between both the parties.

## EXCHANGE OF SCIENTIFIC AND TECHNICAL MATERIAL

VSU and HCS will exchange information on research and educational programmes andteaching/learning material and other literature relevant to their educational and research programmes.

## JOINT CONFERENCES, WORKSHOPS AND SHORT-TERM COURSES

VSU and HCS agree to help identify and invite faculty members from the other institution to participate in conferences, workshops and short-term courses. The terms and conditions for such participation will be worked out by mutual agreement between both the parties.

### INTELLECTUAL PROPERTY

VSU and HCS agree to respect each other's rights to intellectual property. Nothing contained in this MoU shall, by express grant, implication, Estoppels or otherwise create in either Party any right, title, interest or license in or to the intellectual Property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

### **CO-ORDINATION**

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee, consisting of (a) Head of the institute, VSU, or his/her nominee, (b) Director/CEO, HCS, or his/her nominee, (c) Programme coordinator from the side of VSU, and (d) Programme Coordinator from the side of HCS, will periodically review and identify ways to strengthen cooperation between the two institutions.

## TENURE AND TERMINATION

This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for **five years**, and may be continued thereafter after suitable review and agreement. Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither **VSU** nor **HCS** will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, **VSU** nor **HCS** will ensure that all activities in progress are allowed to complete successfully.
