Represented through its Authorized signatory: ANDE PRASAD

Therefore said organizations/ institutions are hereinafter referred to individually as **Partner** and collectively as **Partners**.

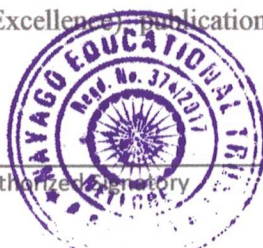
### 2. Purpose:

- d. To promote appropriate joint research projects and joint courses of study, with particular emphasis on national and internationally funded projects.
- e. To provide consultancy on technical aspects related to mutual areas of interest
- f. The Parties through mutual consultations and agreement will discuss and agree upon additional responsibilities, if any

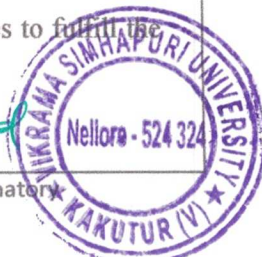
### Objectives:

**i. Programs offered by NET:**

Both the **Partners** have thus arrived at an understanding as indicated below:




**3. Details of Understanding:**

The **Partners**, after due consideration of various aspects, have arrived at the following understanding in respect of the programs mentioned in the earlier paragraphs.

**i. Partner 1 undertakes to impart specifically the following programs for Partner 2:****a. HEMV (Human Ethics and Moral Values) for students:**

- ✓ 5 days, 2 hours each day
- ✓ Program cost : Free
- ✓ Registration valid till there course period ends or for a period 3 years
- ✓ Certificate will be given to participants after completion of workshop

**b. Exclusive Yoga and Meditation Program for all Faculty Members and students of Partner 2:**

- ✓ 5 days, 1 hours each day
- ✓ Program cost : Free
- ✓ Certificate will be given to participants after completion of workshop

**c. SAPE workshop for students of Partner 2:**

- ✓ 3 days, 2 hours each day
- ✓ Program cost :Free
- ✓ Certificate will be given to participants after completion of workshop

**ii. Partner 2 shall provide:**

- Clean, well-ventilated Hall, could be A/C, large enough to accommodate all participants lying down
- Clean Mats / Durries / Gaddas (one per participant) for the Hall, covered with clean sheets
- Stay & Food of the visiting faculty on the campus, during the duration of the program to be provided.
- Material required to conduct workshop like classroom, sound system with mike which is having a facility to interconnect with laptop
- Projector (with Screen) connected to PC, with PCs audio connected to the Venue Audio System.

**4. Duration of MOU:**

This Memorandum of Understanding will come into effect as first above written and on signature of two **Partners** and will be valid for a period of Ten (10) years commencing from effective date and may be extended on which terms and conditions as may be mutually agreed and signed by both **Partners** after review.

**5. Amendments/Modifications:**

This MOU may be amended or modified by a written agreement signed by the representatives of the **Partners** with mutual consent.




**6. Confidentiality:**

Absolute confidentiality of the information exchanged between the **Partners** concerning the subject matter of this MOU shall be strictly maintained.

**7. Termination:**

Either **Partner** may, without any termination obligations and liability, terminate this MOU for any reason by giving written notice of at least one month in advance to the other **Partner**. Before such termination, the **Partner 2** will clear of all dues to **Partner 1** if any before giving the termination notice.

**8. Coordinators:**

Each **Partner** shall appoint one member of its organization or institute as a coordinator to coordinate the program on its behalf. Further, a coordination committee consisting of coordinators from both the **Partners** will communicate, review and find the ways to strengthen the cooperation between the **Partners** to achieve their objectives as mentioned in clause 2 and 2(i) in this MOU.

**9. Legal Effect:**

The **Partners** agree that provisions contained in this MOU do not create any legal obligations between the **Partners**, same for the confidentiality provision and Termination provision in this MOU.

**10. Dispute Resolution:**

In case, there be a dispute relating to any aspect of cooperation authorized representative of **Partners** will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.

**11. Exclusivity:**

During the subsisting of this MOU, **Partner 2** is precluded from having similar arrangements with any other person or third party.

**12. Assignment:**

This MOU cannot be assigned to any third party, without the prior written consent of the other party.

**13. Limitation of Liability:**

Except for claims that may arise pursuant to Confidentiality and termination clauses, in no event shall either Party be liable to the other for any damages including, without limitation, direct, speculative, indirect, incidental, special or consequential damages in connection with this MOU.



**14. Governing Law and Jurisdiction:**

This MOU shall be governed by and construed in accordance with the laws of India and subject to Nellore jurisdiction only.

**15. SIGNED IN DUPLICATE:**

This MOU is executed in duplicate with each copy being an official version and having an equal legal validity. By signing below, the **Partners** or their duly authorized officers have caused this Memorandum of Understanding to be executed, effective as of the day, month and year as first above written. Electronic form of MOU executed signed by any party

**Partner 1** and **Partner 2** welcome the establishment of this Memorandum for understanding and jointly agree to the provisions as set out above.
