

This Memorandum of Understanding (MOU) is entered on 16 day of September 2019 by and between VIKRAMA SIMHAPURI UNIVERSITY, NELLORE, INDIA, the First Party represented herein by its Name of the Competent Authority/representative (hereinafter referred to as "VSU" the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors - in-office, administrators and assigns).

AND

Vijaya Krishna Hospitals, Vijaya Krishna Charitable Society, SPSR NELLORE DISTRICT the Second Party, and represented herein by its Zonal / Divisional Head' Name of Competent Authority / Representative, (hereinafter referred to as "VKS" company which expression, unless excluded by or repugnant to the subject or context shall include its successors - in-office, administrators and assigns).

Both VSU and VKS shall also be collectively referred to as the "Parties" and individually as Party"

SCOPE OF MoU

The MoU between VSU and VKS is to define a mechanism to promote internship programmes, community service projects, Hospital Management Programs and skill enhancement courses for the postgraduate students

OBJECTIVES

- ✓ to support research scholars and faculty working in the area of health sector
- ✓ to act as a bridge between the health sector and the VSU
- ✓ to exchange information on research and educational programmes
- ✓ to jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein
- ✓ to jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty to participate therein
- ✓ to provide internships/research projects to the students at the PG and doctoral levels
- ✓ to conduct health camps at VSU

CO-ORDINATION

The first party, VSU shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee, consisting of (a) Head of the institute, VSU, or his/her nominee, (b) Director/CEO, VKS, or his/her nominee, (c) Programme coordinator from the side of VSU, and (d) Programme Coordinator from the side of VKS, will periodically review and identify ways to strengthen cooperation between the two institutions.

TENURE AND TERMINATION

This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for **five years**, and may be continued thereafter after suitable review and agreement. Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither VSU nor VKS will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, both the parties will ensure that all activities in progress are allowed to complete successfully.

FINANCIAL COMMITMENT

No financial commitment between the parties. However, if there is a financial related aspect both the parties will discuss in a case to case basis.

AMENDMENTS

Any amendment and/or addenda to the AGREEMENT shall be in writing and signed by the PARTIES hereto and shall only after such execution be deemed to form part of the AGREEMENT and have the effect of modifying the AGREEMENT to the extent required by such amendment or addenda.

ARBITRATION CLAUSE

Should there be a dispute relating to any aspect of academic cooperation, Head of the institute, VSU and Director/CEO VKS will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.
